- (v) The Board of Trustees shall ensure proper and safe up-keeping of record of the proceedings of the Board of Trustees i.e. the Minute Book.
- (vi) The Trustees may invest money required for any immediate expenditure in any lawful manner.
- (vii) The trustees shall maintain true and accurate account of all income and expenditures in respect of management of the trust properties or in relation to the carrying out the objectives of the trust and shall appoint independent Chartered Accountant to annually audit all income and expenditures and properties of the trust.

of all expenses actually incurred in connection with duties relating to the trust.

(xx) The trustees may associate with the trust any person or persons of public imminence as patron or patron - in - chief.

(xxi) The Trustees may frame rules, regulations, law, bye-laws, and scheme to regulate and manage the affairs of the Trust.

(xxii) The Trustees may deposit any money, subject to the terms of this Trust Deed and whether required for the expenses of the Trust or not, in any Bank or in any Joint Stock Co. and withdraw the same from time to time as they may decide. They may open accounts with any Bank or banking institution.

(xxiii) No portion of the Trust money shall be lent to, or kept in deposit with, any of the Trustees nor shall any of the Trustees apply any portion of the Trust property or fund for his own use or benefit either directly or indirectly.

(xxiv) Though the trustees shall not be entitled for any salary or benefit from the trust for working as trustees, yet if any of the trustees provides services as a specialist or works full time then the Board of Trustees may fix remuneration for that particular trustee.

(xxv) That this Deed of Trust is subject to amendment by majority vote by $\frac{3}{4}$ of total number of trustees.

Any resolution signed by a majority of the Trustees, on circulation to all the Trustees, shall be as good as passed in a meeting of the Board of Trustees.

7. Chairman of the Board of Trustees :

The Board of Trustees shall be headed by the chairman and the first and founding chairman of the Trust and Board of Trustees will be Mr. Rabindra Kumar, the Trustee, S/o Shri Jageshwer Prasad Singh and he shall hold the post for life. The Chairman shall have the exclusive and undeletable powers:

- (a) To preside over the meetings of the Board of Trustee.

- (c) To have undeletable authority to over-rule the decision of the Board of Trustee and his decision shall be final and bindings, in case a decision is taken contrary to the ethos of trust deed.

- (d) The committee shall have the power to collect funds and donations and offerings on behalf of the Trust if the Board so decides.


